### RELEASE OF LIABILITY

I understand that Sunrun Kennels will not be held responsible for ANY injury, illness or damage caused by my pet(s) and that I am solely responsible. I agree to indemnify and hold Sunrun Kennels harmless from any claims for damages caused by my pet(s).

I understand that even if my dog(s) are currently vaccinated for Bordetella (Kennel Cough) that there is a chance that my dog may still contract Kennel Cough during its stay. I agree that I will not hold Sunrun Kennels responsible if my dog(s) contract Kennel Cough.

I agree that if my dog is the cause of any injury or death to another animal, or the cause of damage to 20322 Riverside Drive, Newport Beach, I shall be fully and legally responsible for the cost of any such injury, death or damage. I agree to fully indemnify SunRun Kennels, its principals, employees or agents for any costs, losses, or legal expenses incurred in the defense of any personal injury or any other claims for negligence, brought by myself or a third party arising from or related to my actions or the actions of my dog while on the premises or in the custody of SunRun Kennels. I have read this paragraph and understand the consequences of any aggressive and/or destructive behaviors of my dog.

I hereby consent and authorize SUNRUN KENNELS for all veterinarian expenses that may occur during or after my dog(s) stay. I also authorize SUNRUN KENNELS to contact my Veterinarian or one of their own choosing should the need arise. This authorization gives the Vet absolute authority to hospitalize said animal(s) and if deemed necessary to treat, medicate, x-ray, call upon the council of a Vet specialist, perform surgery, euthanasia, or autopsy if necessary.

I agree to pay SUNRUN KENNELS for the kennel charges, plus all vet charges while my animal(s) is in their care. These services shall include transportation, medication, hospitalization, x-rays, treatment and general care.

I agree that if I do not pick up my animal(s) within 14 days after the pickup date, SUNRUN KENNELS will consider my animal(s) abandoned and may dispose of my animal(s) in a manner as they see fit. I understand that in doing so, it does not release me from this contract and I must pay all costs of their services, all vet charges and any other charges incurred by my animal(s). Should I wish my pick up date extended, I hereby agree to notify SUNRUN KENNELS before the original pick up date lapses.

I the owner/agent of the above mentioned animal(s) agree that SUNRUN KENNELS shall have the right, to withhold re-delivery of my animal(s) until all services have been paid in full. I further agree that, in the event of my animal(s) death, I am still liable for all charges.

More than one animal quartered in a single kennel must be owned by the same person who assumes all risks of injury due to fighting, disease, infection, etc. unless special instructions are given by the owner in writing.
